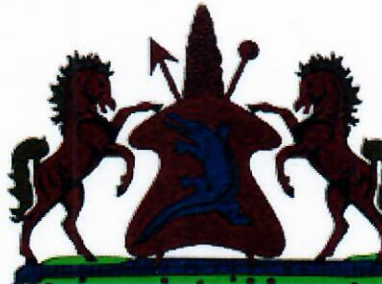

Invitation to Bid for Supply and Delivery of Office Furniture for Transport Infrastructure and Connectivity Project

1. The Ministry of Public Works and Transport has received funding from the Government of Lesotho as a counterpart contribution towards the support of the Transport Infrastructure and Connectivity Project (TICP) and intends to apply part of the proceeds toward payments under the contract for Supply and delivery of Office Furniture for TICP
2. The Ministry of Public Works and Transport now invites sealed Bids from eligible Bidders for supply and delivery of Office Furniture for TICP located at Department of Planning, Former Ministry of Public Works and Transport building, Industrial Area Maseru, Moshoeshoe Road and Opposite to MKM Burial Society
3. Bidding will be conducted through national competitive procurement approach using a Public Procurement Regulation 2007 of the Kingdom of Lesotho and is open to all eligible Bidders registered with the Ministry of Trade and Industry and in good standing in taxes with the Lesotho Revenue Authority.
4. All bidders shall provide valid certified copies of Trader's License and Tax Clearance Certificates issued by relevant authorities in the Kingdom of Lesotho. All copies shall be certified at source. Failure to submit these documents will form grounds for disqualification of the bid
5. Interested eligible Bidders may obtain further information from Ministry of Public Works and Transport, Department of Planning and TICP Procurement Section during office hours from Monday to Friday. This should be done in writing.
6. The bidding documents will be available from **11 to 3rd October 2018 from 0800 – 1600 hrs** and may be purchased by interested Bidders upon payment of nonrefundable fee of **LSL2000.00** to the Ministry of Public Works and Transport,

Accounts Section, first floor, corner senate and Lepoqo roads, opposite to Browns Cash and Carry.

7. The government of Lesotho reserves the right to accept or reject any tender and is not bound to accept a tender with the lowest tender price. What is considered is the tender which provide value for money.
8. The bid security of **LSL10, 000.00** in the form of a **bank guarantee cheque or bank guarantee from an accredited financial institute endorsed with a revenue stamp** should accompany the tender submission.
9. Bids must be hand delivered to the address below on or before **10th October 2018 at 1230hrs** in one original and three copies clearly marked "COPY" and "ORIGIONAL" respectively in one sealed envelope clearly marked "**SUPPLY AND DELIVERY OF OFFICE FURNITURE FOR TRANSPORT INFRASTRUCTURE AND CONNECTIVITY PROJECT**" bearing no identification of the bidder. Bids submitted after the deadline will be rejected. Bids will be publicly opened in the presence of the Bidders' designated representatives and anyone who chooses to attend at the address below on the **10th October 2018 day at 1430hrs** on the physical address given below.
